Reloading UK Trading Terms & Conditions

Carriage

All orders with a value above £50.00 are carriage free for non Hazmat Materials.

Orders that include Hazmat Materials (Ammunition, Powder, Primers) are subject to a £20.00 surcharge.

Delivery

All products will be shipped using a **48 Hour** or **24 Hour** delivery service depending on the delivery service purchased upon checkout.

All products will be shipped the same day if orders are placed **before 16:00**.

In the event of a delayed delivery schedule, unless we receive written confirmation for the cancellation of goods, the said goods will be invoiced as soon as available and the buyer must stand by the original order. The customer must advise Reloading UK Ltd of any partial loss, damage or non-delivery of consignment's within 24 hours of receiving the order onto the customer's premises. No claim can be considered if the consignment has been appropriately signed-for to declare that the goods are complete and in good condition. The responsibility of the goods ends when Reloading UK Ltd hand the consignment to the carrier and provide a tracking number. The sole responsibility of the goods is then handed to the customer.

Returns

Returns for none faulty goods are at the discretion of Reloading UK Ltd and a 20% restocking fee for the initial order value will be taken.

Returned goods shipments are to be arranged via the customer and Reloading UK Ltd will accept no responsibility for returned shipping costs.

Goods returned without prior agreement will be returned to the customer and carriage charges will be invoiced for the required amount. Any goods returned in a 'soiled' or damaged condition will not be subject to refund.

Any goods returned for repair or replacement are subject to manufacturer guidelines and if a UK replacement is not available for immediate dispatch, the customer will be notified of back order status. Any repairs attempted by a third party other than Reloading UK Ltd or the manufacturer will invalidate any remaining warranties. Any faulty goods sold via a retail outlet to 'end user', will be accepted by the retailer and returned to Reloading UK Ltd for replacement. 'End users' replacements will not be dealt with directly by Reloading UK Ltd and therefore retailers must not advise their customers to contact us directly.

Payment

The buyer must pay for the goods no later than **30 days** from the invoice date when using a credit account. Persistent late payment will result in the full withdrawal of all credit facilities and the customer may be subject to legal action.

All payments, regardless of method must quote the applicable invoice number with relation to your consignment.

Interest

Interest at **2% per month** will be charged on overdue invoices not settled within the stated payment terms at the discretion of Reloading UK Ltd.

Pricing Structure

All trade account must have a minimum turnover of £12,000 per annum with Reloading UK Ltd. Any accounts that do not meet this minimum purchase amount may be closed without further notice.

All orders above the £15,000.00 + VAT threshold will be subject to a 2% discount on the total order value.

All pricing structures are subject to change at the discretion of Reloading UK Ltd, however it is our duty to send new pricing structures to all Trade clientele, 30 days prior to price change.

Premises and Location

Reloading UK Ltd reserves the right not to give full account status to new accounts that are in close geographical proximity to existing retail customers. This policy can also be applied when an existing customer opens in a new premises/location.

Selling On

Reloading UK Ltd acts as distributor upon the brands we represent. We therefore reserve the right to withdraw any account status from customers who are actively re-selling our products to other retail businesses, thereby contravening our 'premises and location' policies.

Law

The contract between the supplier and customer shall be subject to English Law and the parties submit to the exclusive jurisdiction of the English courts.

Please allow up-to 28 days from the date of receipt in order to process this form. Please note that completion of this form does not guarantee a trade account will be granted by Reloading UK Ltd.
